Monte Horn Show Horses, owner/agent for the above named stallion, will herein be referred to as
MHSH. This service is subject to the following:

1. The following fees are applicable:
 - a. A non-refundable booking fee of **\$500.00** is due at the signing of this contract.
 - b. The balance of **\$1,250.00** plus shipping fees is payable prior to any shipment of semen.
 - c. Shipped Semen Fees are as follows:
 - Overnight Federal Express **\$250.00**
 - Counter to Counter Air **\$300.00**

NOTE: Mare owner is responsible for returning the Shipping Container back to the MHSH at the
Mare Owner's expense via FedEx.

2. A photocopy of the Mare's registration papers (both sides) shall be sent to BPF with this contract.
3. A live foal is guaranteed from this mating, should the foal not stand and nurse, the Mare Owner will be entitled to return privileges the following breeding season; however, the breeding fee and any additional payments for expenses are non-refundable. The return service in the next breeding season is not transferable to another party. Upon the loss of a foal, the Mare Owner shall provide to BPF a statement from the attending veterinarian stating that the Mare did not produce a live foal.

Mare Owner will be responsible for all additional shipping fees and a \$500.00 chute fee for the return booking.

4. The breeding season in force for this contract shall begin February 1 and close June 15, 2018.
5. A Breeders Certificate will be issued to the Mare Owner only after all expenses have been paid in full and upon notification of a live foal.

6. Should the above Mare die, the Mare Owner shall be entitled to breed a substitute Mare. If the above mentioned Stallion should die or be unfit to breed, breeding fee less the non-refundable booking fee shall be refunded.
7. This contract is not valid unless completed in full. This contract is non-transferable and non-assignable. When signed by both parties, the contract will be binding and subject to the above conditions. The contract is entered in the State of Mississippi under the laws of Mississippi.
8. Semen collections are performed Monday, Wednesday and Friday. MSHS must be notified no later than 7:00 PM CST on the day prior to semen collection to insure availability.
9. If, for any reason, the Mare Owner has not paid their balance in full by June 1, 2018 a service fee of \$100 per month (starting from the month of service) will be added to the outstanding balance and must be paid in full before a breeders certificate is issued.
